- If you complete 1 term of a combined course that includes a lab, document completion of Anatomy lab on your application.
- If you complete 2 terms of combined A&P courses and both include a lab, you should document completion of both Anatomy and Physiology labs.

**Anatomy Lab and Physiology Lab** are not required courses. However, if you are claiming those labs in the "Recommended Courses" section, you must include proof of completion with your application. Acceptable proof of labs include:

- A transcript with the lab grade clearly listed as a separate grade
- A copy of the course syllabus describing the lab component of the course
- A copy of the course catalog page with a description that clearly identifies lab as a component of the course.
- Written confirmation of completion of lab from the course instructor
